

Rite Aid Winter Olympic Sweepstakes

Official Rules

NO PURCHASE IS NECESSARY TO ENTER. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Sweepstakes Period: Rite Aid Winter Olympic Sweepstakes (the “Sweepstakes”) **begins on October 25, 2009 at 12:01:01 A.M. Eastern Time (ET) and ends on December 19, 2009 at 11:59:59 P.M. Eastern Time (ET) (the “Sweepstakes Period”).**

HOW TO ENTER: Two Ways to Enter:

1.) Eligible consumers who participate, in accordance with all applicable terms and conditions, in the Rite Aid Winter Olympics Sweepstakes and who meet all eligibility requirements of these Official Rules, including but not limited to the age and residency requirements referenced under “Eligibility”, below, may enter the Sweepstakes by accessing the Rite Aid Winter Olympics Sweepstakes page at , <https://riteaid.rebateplus.com/sweepstakes> and clicking on the “Rite Aid Winter Olympic Sweepstakes” icon. On-line entries must be submitted by 11:59:59 p.m. Eastern Time (ET) on December 19, 2009 in order for you to qualify for entry in the Sweepstakes.

2.) **Enter without making a purchase** - legibly hand-print your name, complete mailing address including zip code, day time phone number including area code and your date of birth on a 3x5 card or piece of paper. ELIGIBILITY: Sweepstakes is open only to legal residents of AL,CA,CO,CT,DC,DE,GA,ID,IN,KY,LA,MA,MD,ME,MI,MS,NC,NH,NJ,NV, NY,OH,OR,PA,RI,SC,TN,UT,VA,VT,WA,WV, who are 18 years of age or older (19 or older if a resident of AL or NE) as of the date of entry. Not valid in AK, AZ,AR,FL,HI,IL,IA,KS,MN,MO,MT,NE,NM,ND,OK,SD,TX,WI,WY Void where prohibited. Notwithstanding anything contained above, air transportation will not be provided as part of the Grand Prizes if the Grand Prize winners reside within one hundred (100) miles of Vancouver, Canada.
